

**The instrument**, the type and serial number of which are set out overleaf, is hereby guaranteed for a period of 12 calendar months from the date of purchase or hire, subject to the following conditions and exceptions:—

- 1 That during the currency of this Guarantee any components of the Receiver (except pilot lamps, neon tubes, batteries, accumulators, rectifying and receiving valves), which have in the Company's judgment proved to be faulty or defective in manufacture, will be exchanged free of charge, see Clause 3. A separate Guarantee for valves is given below.
- 2 That the servicing of the instrument will be carried out at the place most suitable and convenient to BUSH RADIO Limited.
- 3 *That all Labour involved in servicing, packing, etc., and all carriage costs will be chargeable to the purchaser or hirer.*
- 4 That BUSH RADIO Limited will not accept responsibility for damage caused by:—
  - (a) The use of a fixed voltage instrument upon a voltage higher than that for which it is designed.
  - (b) The use of an instrument having a tapped transformer upon a voltage higher than that for which the transformer is adjusted.
  - (c) The connecting of an A.C. Receiver to an electric supply of lower or higher frequency than that for which it is rated.
  - (d) The connecting of an A.C. Receiver to a D.C. supply.
  - (e) Misuse, wilful or accidental damage.
  - (f) The non-observance of the instructions and information contained in the instruction card.
- 5 That Receivers must be purchased or hired new, and at the Company's full published retail selling or Hire Purchase price, from or through an appointed BUSH Dealer. In the case of a Receiver on Hire Purchase, this Guarantee will not operate unless all instalments are paid up to date.
- 6 That BUSH RADIO Limited reserve the right to change, at their discretion, any Receiver or part of a Receiver sent for service for a like article of approximately the same date of manufacture. This Guarantee shall not be affected thereby.
- 7 That this Guarantee shall become invalid in the event of any unauthorised alteration being made to the instrument for which it is issued, or if any non-standard parts be substituted.
- 8 That any instrument or component part returned to BUSH RADIO Limited under the terms of this Guarantee shall be sent carriage paid.
- 9 That this Guarantee applies only to Receivers purchased and used in Great Britain and Northern Ireland.
- 10 That the following instructions as to procedure are complied with.

## Procedure

In the event of any query, technical or otherwise, apply to the BUSH DEALER from or through whom you bought or hired the Receiver.

If unable to effect such repair as may be necessary, he will arrange for the transfer of the Set to the BUSH RADIO Service Department.

Should you be unable for any reason to communicate with your Dealer, please notify BUSH RADIO Limited direct, giving the type of Set, serial number, date of transaction and full details of your complaint, but do not despatch the Set until advised by BUSH RADIO Limited.

The Guarantee above covers certain material and workmanship only, **and your Dealer, while having no authority to vary the terms as set out above, is entitled to charge for the time taken in effecting any necessary replacements and repairs, all carriage and packing costs being chargeable to you.**

In cases where instruments are returned to BUSH RADIO Limited unnecessarily for causes for which they are not directly responsible, or where the conditions of the Guarantee have not been complied with, all costs involved will be charged to the sender.

The Service under this Guarantee applies only to an instrument having a definite manufacturing defect.

The procedure regarding valves is incorporated in the valve guarantee, set out below.

**This Guarantee is not valid unless the attached slip is signed by the customer and dealer, and returned to Bush Radio Ltd. for registration within 7 days from the date of sale.**

## Valve Guarantee **BRITISH RADIO VALVE MANUFACTURERS' ASSOCIATION**

- ★ The B.V.A. valves used in this Receiver are guaranteed by the valve manufacturer for a period of three calendar months from the date of purchase. This Guarantee is only given in respect of faulty workmanship and material, and does not cover misuse or consequential damage.
- ★ Claims under this Guarantee will only be considered

if the valve is returned to the valve manufacturer, preferably through the radio dealer from whom the set was purchased, supported by proof of the date of purchase of the set as issued by the Set Maker. *To ensure proper examination the right is reserved to break open any valves, if necessary, without obligation to return or replace.*
